1. CALL TO ORDER

4. APPROVAL OF THE MINUTES

A. Approval of the August 26, 2024 and September 9, 2024 Regular City Council Meeting minutes.

Mayor Schweller asked if anyone had comments or corrections to the minutes of the August 26 and September 9, 2024 meeting. Mr. Hoke noted two spelling errors. Hearing no additional, the minutes were declared to be approved.

6. CITIZEN COMMENTS

David Buccalo 126 Lower Hillside. Spoke about Bellbrook Chicken Club having a meeting soon. He noted it was important to get it passed. He noted there were some facts he wanted to clear up noting there is no additional cost to enforce a chicken ordinance, there would not be roosters, and there would be a limit to the number of chickens. He added he hopes it does not take long for the council to consider it. He added residents on Wilmington Pike are concerned about a development in Centerville.

Brad Leonard 1765 Sugar Maple. Spoke about speeding on Little Sugarcreek Road. He stated there are not enough signs and noted there are police cars enforcing the speed. He stated a speed sign has been removed from the flashing speed sign. He added people are not abiding by the speed limit. He asked if it was still wanted to be 25 mph, suggested actions like additional lighted flashing signs, rumble strips or other methods to educate drivers and enforce the speed limit.

Dan Earnst. Noted Ernst Concrete feels itself part of the Bellbrook community. He stated the location of the business is just outside the City and uses Main street as a vital corridor for their business. He added the Ordinance originally proposed was unconstitutional and Council has doubled down and bringing the ordinance back. He noted it is just taking the problems noted and moving them to Wilmington Pike. He added it will have a really bad impact on that part of the City.

Rob Johnson 3875 West Sudbury Court. Spoke about the Springs of Centerville proposed development. He feels Centerville is allowing problems for its neighbors. He noted he reviewed the layout of the proposed development, and it shows one main entrance on Wilmington in the City of Bellbrook and feels it should be on a road in Centerville.

Kieth Cunningham 2115 Ferry Rd. Asked if the Council would be answering questions about the truck ordinance and was informed it was just public comments. He noted he will be back for the public hearing.

Archer Thomas 7440 Wilmington Pike. Spoke about safety of children on Wilmington Pike and noted concerns about increased traffic. He noted there is a damaged guardrail, excessive speed, and concerns about plowing and salting. He also noted there are problems when calling 9-1-1 and getting the dispatcher to know the correct location. He also noted the curve in the road is dangerous. He added a concern about more big trucks that are hard to stop. He asked Council to consider the kids in the area when deciding what to do down the road.

Deborah Schramm 36 S. Main Street. Spoke about concerns about truck traffic on Main Street noting the trucks have increased. She noted the trucks start at 4:30am. She added her house shakes when the trucks go by, and her house was built in 1835. She added the quality of life of the residents living on Main Street is affected. She noted she understands Ernst problems, but there is not tax base for their company to Bellbrook.

Laura Powell. Noted businesses in Bellbrook have truck traffic and should be taken into consideration. She noted their business has grown.

Mayor Schweller mentioned the cost of the downtown revitalization and that it was all funded by grants, ARPA money and dedicated highway and local streets fund based on gas taxes also from the state.

Mr. Harding asked for updates on the flashing crossing lights on Franklin Street at Blue Berry and Dots.

Mr. Greenwood thanked Mr. Schommer for fixing the issue with the Magnetic Springs sign. He mentioned meeting with residents of Bellbrook and Centerville and their concerns with The Springs of Centerville development.

Mr. Harding brought up the Chicken club meeting at the BellHop which is not part of the city it is a private organization.

Mr. Hoke spoke of how nice the work looked that was done to address the flooding in the area of Bellbrock Park and Walnut Street. He mentioned the Spellbrook Halloween held at Bellbrock Park on October 26th.

Mr. Havens thanked all the residents that came forward to speak to the council with their thoughts and concerns. He made note that the parks are there for people to use for functions outside of city officials or city employees' involvement. He spoke of The Springs of Centerville and that the city is going to do everything they can for the residents and their concerns of the development.

He mentioned the speed limit signage along Little Sugarcreek Rd. and East Franklin St.

Mayor Schweller spoke of his concerns of speeding coming into the city on North Main St. and what signage could take place. He addressed the audience that the council is here to work for the citizens of Bellbrook.
